**GENERAL INFORMATION:**

This is an Agility Association of Canada (AAC) sanctioned trial that will be held under AAC rules and regulations. Through submission of their entry, the Competitor acknowledges that they have read and understand the [AAC rules and regulations](#).

All dogs must have an [AAC Dog ID](#) number to compete. This registration should be applied for several weeks in advance of the trial.

**Without exception, all dogs must be penned, crated, or attended on leash when not in the ring.** Dogs that engage in disruptive or repetitive barking or whining should be crated in a vehicle well away from the rings.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or engages in unsafe, disruptive, or aggressive behavior may be asked to leave the show grounds; no refunds will be given.

**An officiating Judge, and/or the Chairperson of the trial, may dismiss from the trial site any person subjecting the Judge, or members, or the organizing committee to abuse, whether that person is competing in the trial or not.**

Prong collars, choke chains, e-collars and other similar devices are not permitted on the property at any time. Extendible leashes may only be used on the walking trails/open field and must kept at their shortest length and locked when another dog or person is within 50'.

**NOTICE:**

Confirmations will be emailed weekly ahead of the trial closing. If you do not receive an official entry confirmation and invoice by the closing date, please contact the Trail Secretary.

Refunds will only be issued if the Trial Secretary is notified before the trial closes, the trial is canceled due to Provincial regulations related to COVID, or if the dog is unable to compete for medical reasons; a veterinary note must be provided.

Preliminary running orders will be posted [online](#). Final running orders will be emailed to all competitors and posted online the day before the trial. Once the final running order is posted, no further changes will be made.

## Special requirements for Females in Season

1. Handlers are required to notify the trial secretary that they will be running a BIS at the event as soon as it is known.
2. Any competitor will be allowed to withdraw their intact female entered from this event and offered a refund or credit.
3. Competitors will be notified there is a BIS on site.
4. A protective mat shall be used at the start line. This will be supplied by the club. Handlers may adjust the mat to a place of their choosing for their dog to start from.
5. Females in season will be required to wear protective pants at all times – except while being crated, or in the designated potty area.
6. BIS will run as a group at the end of each class, regardless of class or jump height.
7. "BIS" will be noted next to the dog's name on the gate sheet and will be highlighted in pink for all competitors to be informed.
8. BIS must use a designated relief area. Competitors will be permitted to park near this area in order to minimize impact on other competitors.

## COVID-19 General Policies & Procedures for AAC Events

1. Masks must be worn at all times during briefings, course walk-throughs, and when social distancing cannot be observed.

**If you are unable to wear a mask for any reason, we ask that for your protection – and the protection of others – that you do not register for or attend this event.**

2. Masks (cotton, cotton blends, and medical) must be tightly fitted, and completely cover the nose, mouth, and chin. Face shields, wool, knits, scarves, buffs, etc...are not acceptable face coverings.
3. All Provincial guideline regarding individuals with COVID symptoms, pending test results, positive test results, and isolation requirements must be observed. Please consult the most up to date Ontario Provincial guidelines to determine whether you can attend this event or not.
4. Guests of the participant must also adhere to provincial guidelines.

## General Agreement

### /Event Participation Waiver and Release

In consideration of the acceptance of this entry by AAC and Millennium Dog Sports (the "Organizing Club") and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the "Event"), I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the "Personnel") for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers' fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to: (a) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or (b) aggressive behaviour by the Dog or any other dog under my control.

5. I have read and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the "Rules"). I agree to abide by the Rules and to conduct myself and the Dog in accordance with the Rules. I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.

6. I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information. Media Release & Rights of Privacy Waiver I Hereby Grant to AAC and its affiliated companies, representatives, agents and assigns, all rights and permission to use or appropriate his/her and their dog's name, biography, likeness, photograph, voice, performing persona, or other indicia of identity for broadcast, telecast, cablecast, transmission or distribution in any format or media known now or in the future. Waiver of Rights to Privacy, Publicity & Personality Further, I hereby release Agility Association of Canada Inc, and its affiliates, representatives, agents and assigns from any claim or cause of action for invasion of the rights of privacy, right of publicity, right of personality, or any similar rights.
